Classroom Management Plan: Letter to Parents

Dear Parents,

We are looking forward to working with your child this year. An important part of your child being successful in our classrooms is his/her learning how to behave appropriately. To help your child and the entire class, we have developed a classroom management plan:

Classroom Rules:

- Follow Directions

 Follow directions the first time they are given
 Thoroughly read and follow directions on assignments and tests
- 2. Use Appropriate Behavior
 - -Use appropriate verbal and written language on class assignments and when using technology
 -Use appropriate verbal and written language when interacting with peers and adults
 -Make good choices to keep yourself and others safe
 -Follow social distancing guidelines
- 3. Be Academically Prepared

-Complete and submit daily assignments on-time (including absent work and online assignments)
 -Have appropriate materials and supplies each day
 -Communicate academic concerns and questions to teacher(s) daily

4. Be Personally Prepared

-Follow school dress code each day -Keep desk, locker, and personal space clean and organized -When required, wear and use Personal Protective Equipment properly

- 5. Be a good example of your faith
 - -Treat others the way you would want to be treated -Be kind and accepting of others and their differences always -Accept the consequences of your actions

Your support is very important as well. It is important that your child knows you support him/her behaving in our classrooms, so we would appreciate your support when you get feedback from us. However, if your child chooses to break a rule, the following steps will be taken:

Consequences:

- 1. Verbal Warning (You will be given a verbal warning to correct your behavior)
- 2. Check Mark (If you do not correct your behavior, you will earn a check mark)
- 3. Demerit (If you earn 3 check marks in one week, you will then earn a demerit)
- 4. Detention (If you earn 3 demerits in an academic quarter, you will earn a detention)
- 5. Suspension (If you earn 3 detentions in an academic quarter, you will earn a school suspension) *Behavioral consequences are subject to the discretion of the teacher and/or principal*



Rewards:

- Tier 1: (Individual students with NO CHECKS at the end of the week will earn 15 minutes of Friday free time; students who have earned check marks will not participate)
- Tier 2: (If the class as a whole has NO CHECKS for the entire week, the class will earn 25 minutes of Friday free time)
- Quarterly: (At the end of each quarter, students who have earned a merit will be entered into a drawing to win a reward from the principal)

Chromebook Permission Form

Parents/guardians have the right to know their child's login password. Your student should be able to provide you with his/her username and password. Your child's password can also be requested if needed.

Additional Expectations:

*Students will only download teacher-directed apps for educational use

- *Students will only visit teacher-directed and approved websites
- *Students will carry the Chromebooks with two hands and the lid closed
- *Students will keep all food and water bottles away from the Chromebook at all times

*Students will not login to any person accounts from the Chromebook (i.e. Netflix, Disney+, Hulu, etc.)

*If damage is done to the device, students and their family will be responsible for the cost of repair which will be decided by the principal

*Students who are found to be sharing or copying documents from others will be considered cheating and will receive an automatic zero on the assignment

*Headphones/ear buds will not be used during class time unless directed by the teacher

*While Chromebook is not in use, the device should be closed and stored properly on top of the student's desk
